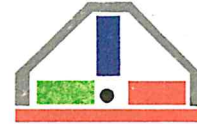

**TELPOSTA PENSION SCHEME AND PROVIDENT FUND**  
**ELECTION OF ONE (1) MEMBER NOMINATED TRUSTEE**

The Term of one (1) Trustee, **Mr. John Peter Mdhune Onginjo** was to expire after 2020 May AGM and consequently there was to arise one (1) vacancy for election of Member Nominated Trustee during 2020 AGM to fill one (1) Trustee slot. However, since the 2020 AGM and Elections were not held, Mr. John Peter Mdhune Onginjo has continued to serve as a Trustee.

The Scheme/Fund will now hold the election of one (1) member nominated Trustee as stipulated below:

**Date: 14<sup>th</sup> June 2021**

**Time: 8.00 A.M to 5.00 P.M**

**Avenue: Mobile Phone Voting System**

**NOTE:**

- a) The procedure for using Mobile Phones to vote shall be shared later.
- b) All members of TelPosta Pension Scheme and TelPosta Provident Fund (including Leavers with Preserved Benefits) are eligible to contest.
- c) All interested contestants are required to immediately collect a Fit & Proper Test Form from the Secretariat Offices or download from the Scheme Website [www.telpostapension.org](http://www.telpostapension.org) fill and return by close of business on **24<sup>th</sup> May 2021**.
- d) In this elections, contestants shall not be required to fill nomination forms or obtain signatures from members as was the case for previous elections.
- e) Any person nominated to be a Member Nominated Trustee shall be required to produce the following documents (and any other documents that may be specified) to prove that they are citizens of good standing:-
  - (i) Certificate of Good Conduct from Directorate of Criminal Investigations (DCI)
  - (ii) Tax Clearance Certificate from Kenya Revenue Authority (KRA)
  - (iii) Certificate from the Credit Referencing Bureau (CRB)

- f) Members shall only be able to vote using the Specific Mobile Phone Numbers that they have provided to the Scheme/Fund.
